After inhalation:

In case of unconsciousness place patient stably in side position for transportation.

Supply fresh air

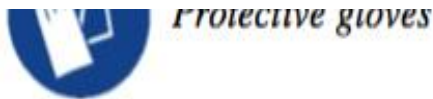

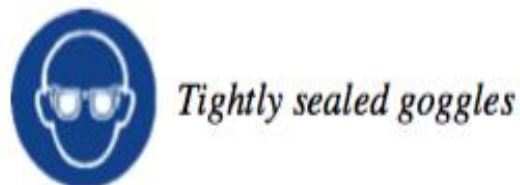
The selection of the suitable gloves does not only depend on the material,
