## Section 4. First-aid Measures

### 4.1 Description of first aid measures

- General advice : Move out of dangerous area.  
Never give anything by mouth to an unconscious person.
- Skin contact : Symptoms: dry skin, irritation in case of repeated or prolonged exposure.
