Inhalation

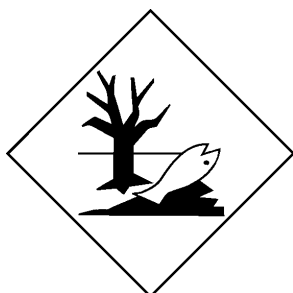
