8.2 Exposure controls

Exposure assessment: Exposures are dependent on the product being handled, the potential for chemical release, and any resulting airborne concentrations or dermal contact. Since product handling and release scenarios vary, and no two workplaces are exactly alike, it is recommended that the potential for exposure be assessed prior to the product's use or introduction. Exposure assessments should be performed by an occupational hygienist, industrial hygienist, or other qualified occupational or environmental health professional. An exposure assessment should be conducted to determine the efficacy of any ventilation and the need for additional PPE. The PPE indicated below are recommendations for worst-case scenario exposures. The PPE selection is for operators trained to work with chemicals according to good industrial hygiene and safety practice. Operators have to be trained on the use of PPE.
